- 1. While the greatest possible care will be executed by the management to protect patrons of the Dodge County Fair, each individual will be held personally responsible for his or her actions, and the management will not be accountable or responsible for any injury.
- 2. The Dodge County Agricultural Association management assumes no liability for loss or damage to any property of the concessionaire, exhibitor, or patron, due to theft, fire, tornado, weather conditions, or other causes.

#### **GENERAL RULES**

- 1. Entries are limited to FFA members with their advisors in the following FFA Chapters: Byron, Blooming Prairie, Hayfield, Kasson-Mantorville, Kenyon-Wanamingo, Pine Island, Stewartville, and Triton.
- 2. All health regulations governing open-class livestock will be in effect.
- 3. Livestock entries must have been in possession of the exhibitor for at least 30 days prior to the fair.
- 4. Deadline for entries is **June 30th**. Entries must be turned in to the local FFA advisor or online with the penning fee of \$2 per head for dairy, beef, swine, goat, and sheep. Poultry and rabbits will be charged a penning fee of \$1.00 per animal. NO EXCEPTIONS AND NO REFUNDS ARE AVAILABLE.

- 5. Health certificates must be available at the time livestock are unloaded. See "Notice To All Exhibitors Of Livestock".
- 6. Each exhibitor must keep his/her pens and alleys in front of his/her pens clean at all times during the fair.
- 7. If the livestock entry is also entered in the 4-H or open class show, please indicate this on the entry sheet.

#### **GENERAL RULES FOR ALL EXHIBITORS**

- 1. All articles exhibited must be the property of the exhibitor and except in designated classes, must be made, manufactured, or raised by the exhibitor. Livestock entries must have been in possession of the exhibitor for at least 30 days prior to the fair.
- 2. No animal or article unworthy of a premium shall receive one, even though there be no competition.
- 3. The decision of the judges shall be final in all cases except where mistakes, fraud, or misrepresentation not discovered at the time of the award is made, is apparent. In such cases, the Board of Directors' decision is final.
- 4. NO PREMIUMS WILL BE PAID FOR ANY DISPLAY OR EXHIBIT IN ANY DEPARTMENT TAKEN OUT BEFORE THE REGULARLY SCHEDULED RELEASE TIME.
- 5. No more than one entry, except livestock, can be made in the same lot by an exhibitor. Advisors reserve the right to create breed classes or consolidate breed shows based on registration numbers.
- 6. FFA members will be eligible to exhibit if they meet the requirements of being an FFA member in good standing with their local chapter. Completed 7<sup>th</sup> graders are eligible to exhibit at the county fair. Graduates from high school may exhibit four (4) county fairs following the student's graduation from high school

#### **RULES FOR LIVESTOCK EXHIBITORS**

- 1. Animals are eligible to be entered in all 3 shows, FFA 4-H and Open Class as long as they are in good standing.
- 2. No more than two entries per lot can be made by the same exhibitor.
- 3. TAKE NOTICE Entries close June 30 or when barns or pens are filled. Please send entries to your local FFA advisor or enter online.

#### NOTICE TO ALL EXHIBITORS OF LIVESTOCK

FFA members register Livestock with their local FFA advisor – by June 30. An FFA entry form MUST be filled out for all animals, even if an Open Class entry form has been completed. There is an entry fee of \$2.00 per head for dairy, beef, goat, sheep and swine. An entry fee of \$1.00 per head for rabbits and poultry. Checks should be made out to *Dodge County Fair* and must accompany the entry form.

- 1. No animal shall be awarded more than one FFA premium except for herd sweepstakes, special premiums, or as part of a group.
- 2. Exhibitors must keep their stalls and pens in good, neat condition and open for inspection from 10:00 a.m. to 10:00 p.m. and properly identify their exhibits (ex. Stall Card). If showing FFA and Open Class will be stalled with their Open Class
- 3. Livestock exhibitors are limited to two entries per lot, except groups; only one entry is permitted.
- 4. All livestock will be inspected by the official veterinarian on the opening date of the Fair. <u>It is the</u> <u>exhibitor's responsibility to be aware of and follow all the rules, regulations, and policies of the MN</u> <u>Board of Animal Health in regard to any and all diseases.</u>
  - a. All out-of-state cattle shown at public exhibitions are to be accompanied by a health certificate issued by an approved veterinarian within 90 days prior to the opening date of the exhibition and executed on the official health certificate from the state. HEALTH CERTIFICATE shall include the required brucellosis records. Cattle from other states will require a Tuberculosis negative test.
  - b. Out-of-state sheep must be accompanied by a Health Certificate certifying that the sheep for exhibition and the flock of origin have been inspected and found free of scabies or other infectious diseases within 30 days prior to the opening date of the exhibition. Sheep breeding stock must have an official scrapies identification tag. Wethers are no longer exempt and must also have a tag.
  - c. A Scrapie Program-approved tattoo or a scrapie tag is required for the identification of goats, however, tattoos are preferred. Meat Goats can be tattooed after five days of age.
- 5. All Bulls must be double-tied.
- 6. ALL HEALTH CERTIFICATES MUST BE AVAILABLE AT ARRIVAL OF LIVESTOCK ON THE FAIRGROUNDS.
- 7. The official veterinarian of the fair shall have full authority in all matters of livestock sanitation as the representative of the board. It is suggested that all livestock exhibitors contact the official veterinarian as soon as possible.
- 8. The fair management will use diligence to ensure the safety of livestock or articles entered for exhibition, after their arrival and placement, but under no circumstances will it be responsible for any loss, injury, disease, sickness, or damage done to, or occasioned by or arising from any animal or article on exhibition, and the exhibitor shall indemnify the fair and management thereof against all legal or other proceedings in regard thereto.
- 9. Bedding will <u>not</u> be furnished by the fair association. Exhibitors are to furnish bedding and feed.
- 10. No one, except the caretaker, designated by the Fair Board, shall stay in livestock barns at night.
- 11. Due to show conflicts or 2<sup>nd</sup> animal per lot, animals need to be shown by an FFA member whenever possible. In case of illness, or other extenuating circumstances, an exhibitor may substitute another FFA member to show the entry. The substitute, however, must be pre-approved by the department superintendent. **All persons leading or driving an animal into the judging area must be FFA members.**

The show will be split into **non-dairy and dairy** classes Based on the number of entries, classes **will be divided** at the discretion of the show committee.

#### **Mouthing of Meat Goats**

Goats may have lost 1 or more milk teeth but there may be no evidence of breaking of skin or eruption of 2 permanent teeth.

#### Poultry Penned by 7:00 p.m. on Tuesday, Poultry Released after 4:00 p.m. on Sunday

- 1. **Ownership**. Pedigree or transfer certificate must include the proper name of the FFA exhibitor as an owner (except as noted).
  - a. Animals owned in partnership. 100% of the pedigree or transfer certificate must be in the name of a partnership by June 1 of the current year.
    - 1. Immediate family. Defined as spouse, parent, sibling, or grandparent.
    - 2. Out of family. Not permitted.

#### 2. Animal Identification.

- a. All birds must be marked by numbered bands around one leg. Unbanded birds will not be allowed in the showroom.
- 3. Poultry exhibitors will be permitted to show two pens per class.
- 4. Age restrictions. All young birds exhibited must be 16 weeks of age or older in the egg-laying or breeding classes or they will be barred from competition. On any birds in question, the decision of the superintendent is final. Requirements for individual market classes are listed for each individual class below.

#### 5. Definitions.

- a. Cock. Male birds hatched prior to 2023.
- b. Cockerel. Male bird hatched in 2023.
- c. Hen. Female bird hatched prior to 2023.
- d. Pullet. Female bird hatched in 2023.
- 6. **Poultry Health Regulations and Identification.** Defined as chickens, game birds, turkeys, and waterfowl raised in captivity. Doves and pigeons are excluded. Baby poultry is defined as newly hatched poultry that have not been fed or watered.
  - a. **Identification**. All chickens, game birds, and turkeys must be identified by a leg or wing band. Waterfowl and baby poultry are exempt. Young poultry that are too small to band may be exhibited as a group if the Hatchery Permit number or National Poultry Improvement Plan (NPIP) number is on the cage.
  - Certificates or test charts. All chickens, game birds, turkeys, and hatching eggs from these birds must be accompanied by a certificate or test chart demonstrating compliance with the following testing/disease requirements. Testing is available at the Minnesota Poultry Testing Laboratory, Willmar, Minn., 320-231 -5170.
    - 1. **Chickens and game birds**. Must originate from a hatchery or breeding flock that is classified under the National Poultry Improvement Plan (NPIP) as pullorum-typhoid clean; or be negative to a pullorum-typhoid test within 90 days prior to the opening of the exhibition.
    - 2. **Turkeys**. Must originate from a hatchery or breeding flock that is classified under the National Poultry Improvement Plan (NPIP) as pullorum-typhoid clean, Mycoplasma gallisepticum clean, and Mycoplasma synoviae clean; or be negative to a pullorum-typhoid, Mycoplasma gallisepticum and Mycoplasma synoviae test within 90 days prior to the opening of the exhibition.
    - 3. Waterfowl. Exempt from testing requirements.

#### c. Poultry from outside Minnesota.

- 1. **Requirements**. Must meet the test requirements listed, plus the Minnesota Importation requirements. See bah.state.mn.us/imports/, or call the Minnesota Poultry Testing Laboratory (MPTL) at 320-231 -5170.
- 2. **Import permit.** An Annual Import Permit may be obtained by completing an application and submitting to your official state agency for endorsement or a Single Move Import Permit may be obtained by completing a Single Move Request form, or by calling the MPTL at 320-231-5170.
- d. **Certificates.** All hatching eggs, poultry, and ratites must be accompanied by a certificate indicating how the specific disease requirements have been met. a. Examples. A CVI, NPIP Form VS 9-3, NPIP Form VS 9-31, NPIP Form VS 9-2, or an official test record demonstrating compliance with the specific disease requirements.

#### e. Specific disease requirements.

- 1. All hatching eggs, poultry, and ratites must originate from a NPIP approved hatchery or breeding flock that is classified as pullorum-typhoid clean under the plan; or be individually identified with a leg or wing band and be negative to a pullorum-typhoid test conducted within 30 days prior to importation.
- 2. All turkey-hatching eggs, poults, and turkeys must also originate from a hatchery or breeding flock that is classified Mycoplasma gallisepticum clean and Mycoplasma synoviae clean under the plan; or be individually identified with a leg or wing band and be negative to a Mycoplasma gallisepticum and a Mycoplasma synoviae test within 30 days prior to importation.

#### Rabbits Penned by 7:00 p.m. on Tuesday, Rabbits Released after 4:00 p.m. on Sunday.

#### 1. Animal identification.

- a. All rabbits must be plainly marked with permanent marking (tattoo). No exhibit will be accepted unless permanently marked.
- 2. Rabbit exhibitors will be permitted to show two entries per class, except in market individual fryer class, where three entries are allowed. To show in market pen class, animals must be shown individually.
- 3. **Stalling** Rabbits will be penned in the Poultry Barn
- 4. Definitions. Base dates for rabbits will be Sept. 2, 2023.
  - a. Senior Over eight months of age/large breeds, over six months of age/all other breeds.
  - b. Intermediate Over six and under eight months of age. Not over the standard weight for the breed.
  - c. Junior Under six months of age for all breeds, and not over standard age weights.
- 5. **Rabbit Health Regulations and Identification**. Diseased rabbits unfit to be shown may be barred from competition by the department superintendent. Rabbits showing symptoms of disease at time of arrival or during the exhibition will be disqualified and returned to the owner immediately.
  - a. Identification. All rabbits must be plainly marked with permanent marking (tattoo). No rabbits will be accepted unless permanently marked.
  - b. Certificate of Veterinary Inspection (CVI). Not required.
