Dear Open Class Animal Superintendents and Exhibitors,

On behalf of the Dodge County Fair Board, we are excited to have everyone participate in this year's 169<sup>th</sup> Dodge County Free Fair. With the continued expansion of the fair, increase in livestock numbers, and safety of all those attending; the Fair Board is continuing with last year's livestock parking procedures.

Open Class Livestock Parking will continue to be split dependent on what type of species. Open Class Goat, Rabbit, and Sheep will continue to be allowed to park near the livestock barns on the day of their show. There will still be two areas of parking available for them. One will be on the north road next to dairy and beef barns, which will have spots marked out on the road next to Houston's that you will be able to park. The second will be on the west side of the Show Arena. There will be no parking in between the show arena, dairy, horse, and rabbit/poultry barns or on the east side of the dairy or horse barns. Open Class Beef, Dairy, and Horse Parking will be located down by the Horse Arena next to Grandstand and beef tie outs. There are livestock shuttles available to help shuttle anything up near the Show Arena. Failure to obey our parking signs will be subject to towing at the owner's expense. Open Class Exhibitors are allowed to leave once their shows are complete.

Superintendents, you will be parking on the west side of the show arena. There will be designated parking spots for you. You can stop at the office to pick up your parking pass or at the fair picnic.

We understand that this is still new and there continues to be growing pains, but we ask for your continued patience and understanding in this matter. Safety is our top priority for all fair participants. If you have any further questions, please contact the following.

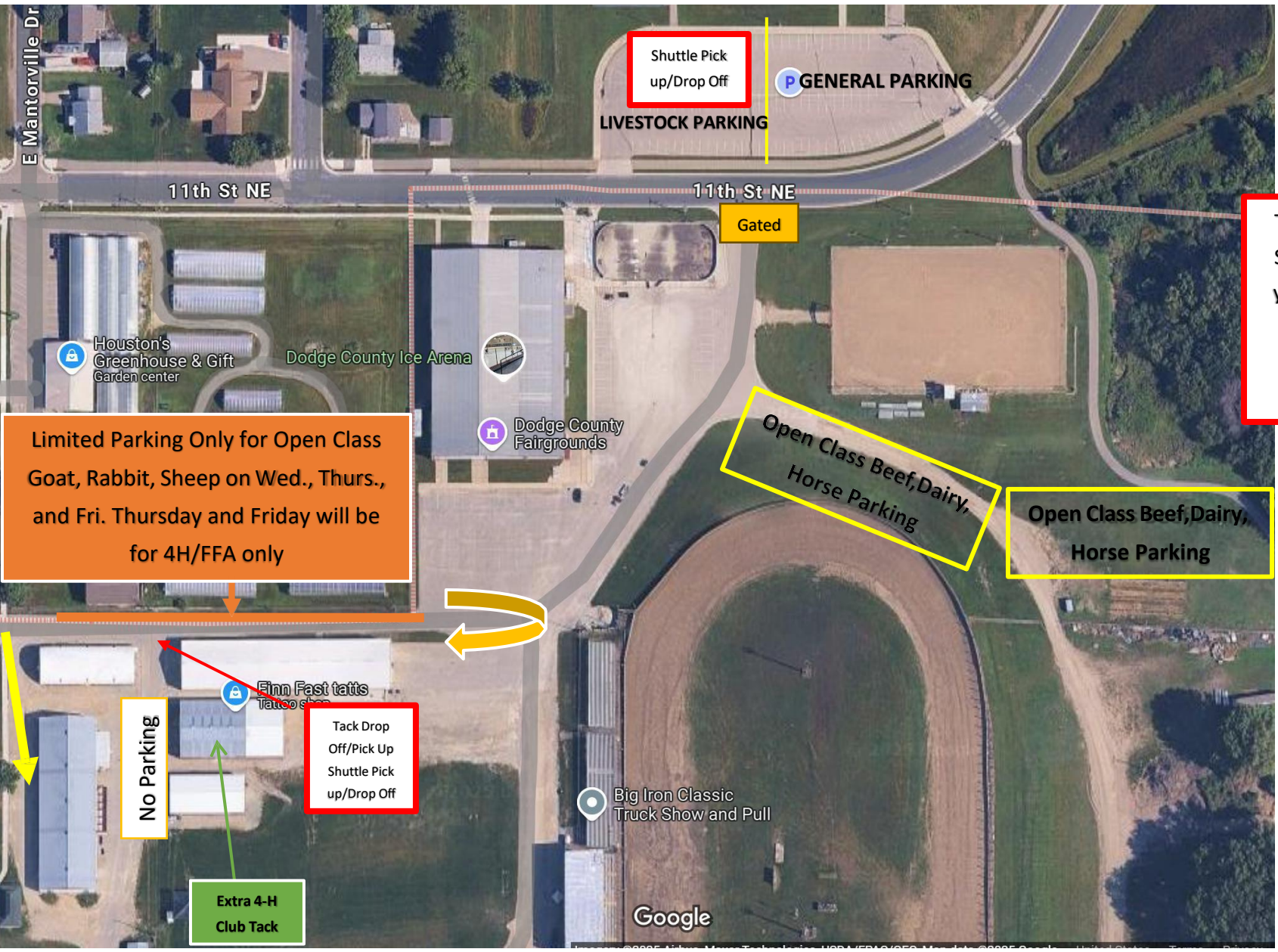
